- 2. The rates are Net inclusive of all taxes; duties etc. and nothing Extra shall be paid.
- 3. Income Tax etc. will be deducted as applicable on the value of work done.
- 4. The deviation limit shall be $\pm 10\%$.
- 5. The contractor is required to follow all labour laws, Minimum Wages Act and other provision to labour welfare applicable from time to time. Nothing extra shall be paid for the same.
- 6. The work shall be executed without any loss/damage to THSTI properties etc.
- 7. The total work Included: -
 - I. Supply, Installation, Termination & Testing of electrical system as per Govt. guidelines.
 - II. Testing of the electrical system should be done by the agency.
- 8. Any damages occur during the execution of work, the same should be rectified by the contractors on their own cost.
- 9. Contractor shall be fully responsible for safety of his workers and in case of any misshaping the entire responsibility shall be on the contractor.
- 10. The Contractor shall clean the site after completion of work in all.
