Translational Health Science and Technology Institute (THSTI) is an autonomous institution of the Department of Biotechnology, Govt. of India and is a part of the interdisciplinary Biotech Science Cluster at Faridabad in the National Capital Region. The institution is designed to be a dynamic and interactive enterprise with a mission to conduct innovative translational research and develop research collaborations across disciplines and professions to accelerate the extension of concepts to improve the human health. The cluster institutions will have access to state-of-the-art experimental animal facility, biosafety level 3 laboratories and technology platform resources.

Centre for Biodesign and Diagnostics (CBD) has been established as a niche centre of THSTI. The primary mission is to promote science and application related to affordable implants, devices, invitro diagnostics and imaging. The centre will promote an effective translational route of basic findings ultimately into routine applications of major importance, through a multidisciplinary approach, combining new bio markers, novel technological concepts and clinical expertise. Major areas of research in the field of in-vitro diagnostics will include protein and antibody engineering, recombinant protein production, biomarker discovery, detection technologies and concepts, nucleic acid diagnostics, decentralized diagnostics (Point-of-Care), bio-organic chemistry diagnostic technologies, bio-affinity test concepts and systems, microfluidics, miniaturization, different reporter alternatives and multiplexing.

Job Description:

Work in the area of innovative approaches to in-vitro diagnostics which include biomarker discovery/protein and antibody engineering/recombinant protein production/ Point -of-care diagnostics.

Grant for equipment, computational and communication facilities, consumables, contingencies and travel required for the proposed innovation project submitted along with the application will be met from the core grant of the biodesign program on in-vitro diagnostics.

Essential requirements:

- Applicant should possess a PhD / MD / MTech in any branch of Science/Medicine (Life / Chemical / Physical / Engg.). Applicants, who have submitted their thesis and awaiting their degree, are also eligible to apply. Applicants should have a proven/ outstanding track record as evident from research publications, product developed and recognitions.
- Applicants will be required to submit an innovation project proposal of about 2000 words in the field of advanced diagnostics research and application.

• Submission of reference letter from the guide/supervisor/employer/HOD/Director of Institute is essential. The Reference letter should indicate the candidate's competence for the award and should be sent directly in confidence to the Head - Administration by email (recruitment@thsti.res.in.)

Desirables

- Preference will be given to those with interest and expertise in in-vitro diagnostics /recombinant DNA technology/infectious diseases/protein and antibody engineering/ recombinant protein production/ biomarker discovery.
- First class grades in examinations of all academic courses for award of a degree from the graduate level onwards.
- Cumulative publication impact factor of 10.
- Cumulative publication impact factor of 5 with two published Indian Patents or one International patent.

GENERAL TERMS & CONDITIONS:

- 1. Appointment will be made on contract basis which will co-terminate with the project. There will be an initial probation period of 6 months that may be extended at the discretion of the competent authority.
- 2. Positions will be initially based in the THSTI's interim laboratories at Gurgaon and will be shifted to its permanent campus in Faridabad when ready.
- 3. All educational, professional and technical qualification should be from a recognized Board/University.
- 4. The experience requirement specified shall be experience acquired after obtaining the minimum educational qualifications required for the post. Experience backed up by sound original peer-reviewed research publications will be important for selection.
- 5. The age limit, qualification, experience and other requirements for the post are relaxable at the discretion of the competent authority, in case of candidates otherwise well qualified.
- 6. Persons working in Govt. or Public Sector undertaking or Autonomous body should apply through proper channel or produce 'No Objection Certificate' at the time of Interview.
- 7. Incomplete applications will stand summarily rejected.
- 8. In case of receipt of a large number of applications are received, screening will be done to limit the number of candidates to those possessing higher/relevant qualification / experience.
