### RECRUITMENT FOR SCIENTIFIC POSITION

- a) Translational Health Science and Technology Institute (THSTI) is an autonomous Institute of the Department of Biotechnology, Ministry of Science and Technology, Govt. of India. The institute is an integral part of the interdisciplinary NCR Biotech Science Cluster located at Faridabad, and is designed as a dynamic, interactive organization with the mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into tangible products to improve human health.
- b) THSTI has set up niche centres for research in areas relevant to planned translational work. They are: Vaccine and Infectious Disease Research Centre (VIDRC), Paediatric Biology Centre (PBC), Centre for Bio-design & Diagnostics (CBD), Drug Discovery Research Centre (DDRC), Centre for Human Microbial Ecology (CHME) and Policy Centre for Biomedical Research (PCBR). Clinical Development Services Agency (CDSA) and National Bio-design Alliance (NBA) are THSTI's extramural centres.
- c) This recruitment is to fill up the scientific vacancies of THSTI under its centre CHME.
- d) The vision of Centre for Human Microbial Ecology (CHME) is to understand the dynamics of human microbiome and its influence on various clinical outcomes such as prematurity, malnourishment and response to vaccinations. Its aim is to harness the human microbiome for providing knowledge-based solutions for public health. The mission of CHME is to create a multi-disciplinary research centre designed to conduct basic, clinical and translational research on the role of the human microbiome in health and disease.

### **GENERAL TERMS & CONDITIONS:**

- 1. Appointment will be made on contract for a period upto 9th July 2018 with a probation period of one year.
- 2. All educational, professional and technical qualification should be from a recognized Board/ University.
- 3. Persons working in Govt./ PSUs/ autonomous bodies should apply through proper channel or produce a relevant 'No Objection Certificate' at the time of written test/ skill test/ interview .
- 4. The experience requirement specified shall be experience acquired after obtaining the minimum education qualifications specified for the post.
- 5. Age and other relaxations for direct recruits and departmental candidates: 1. By 5 years for candidates belonging to SC/ST communities. 2. By 3 years for candidates belonging to OBC communities. 3. For Persons with Disabilities (PwD) falling under the following categories: (i) UR 10 years, ii) OBC 13 years (iii) SC/ST 15 years 4. For Ex-servicemen upto the extent of service rendered in defence forces (Army, Navy & Air force) plus 3 years provided they have put in a minimum of 6 months attested service. 5. Relaxation of 5 years will also be permissible to those who had ordinarily been domiciled in the Kashmir division of the State of Jammu and Kashmir during the period from 01/01/1980 to 31 /12/1989 subject to production of relevant certificate from concerned authority. 6. Age is relaxable for Government servants up to 5 years in accordance with the instructions or orders issued by the Central Government, from time to time 7. There is no upper age limit for the Institute employees who are treated as departmental candidates.

- 6. The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates.
- 7. The age limit, qualification, experience and other requirements may be relaxed at the discretion of the competent authority, in case of candidates who are otherwise suitable. In case candidates are not found suitable for the posts notified, they may be offered lower post / lower emoluments on the recommendation of the Selection Committee.
- 8. Number of positions filled will be as per the Institute's need and availability of the suitable candidates.
- 9. Number of vacancies may vary based on the requirement at the time of written test/ skill test/ interview.
- 10. Outstation SC/ST/PwD candidates called for the written test/ skill test/ interview will be paid to & fro second class railway fare, as per Govt. of India rules on production of the proof of travel.
- 11. In case a large number of applications are received for each post, screening will be done to limit the number of candidates to those possessing higher/ relevant qualification and experience.
- 12. Only shortlisted candidates will be called for written test/ skill test/ interview.
- 13. All results will be published on our website and all future communications will be only through email.
- 14. Canvassing in any form will be a disqualification.
- 15. Interested candidates are requested to submit the online application on or before the last date and send the signed hard copy of application with all enclosures on or before the specified date.
