## **GENERAL TERMS & CONDITIONS:**

- 1. Appointment will be made on contract for a period of one year with initial probation period of six months that may be extended at the discretion of the competent authority.
- 2. All educational, professional and technical qualification should be from a recognized Board/University.
- 3. The experience requirement specified shall be experience acquired after obtaining the minimum educational qualifications required for the post.
- 4. Persons working in Govt./ PSUs/ autonomous bodies should apply through proper channel or produce a relevant 'No Objection Certificate' at the time of written exam/skill test.
- 5. The age limit, qualification, experience and other requirements may be relaxed at the discretion of the competent authority, in case of candidates who are otherwise suitable. In case candidates are not found suitable for the posts notified, they can be offered lower post / lower emoluments on the recommendation of the Selection Committee.
- 6. Age and other relaxations for direct recruits and departmental candidates: 1. By 5 years for candidates belonging to SC/ST communities. 2. By 3 years for candidates belonging to OBC communities. 3. For Persons with Disabilities (PwD) falling under the following categories: (i) UR 10 years, ii) OBC 13 years (iii) SC/ST 15 years 4. For Ex-servicemen upto the extent of service rendered in defence forces (Army, Navy & Air force) plus 3 years provided they have put in a minimum of 6 months attested service. 5. Relaxation of 5 years will also be permissible to those who had ordinarily been domiciled in the Kashmir division of the State of Jammu and Kashmir during the period from 01/01/1980 to 31 /12/1989 subject to production of relevant certificate from concerned authority. 6. Age is relaxable for Government servants up to 5 years in accordance with the instructions or orders issued by the Central Government, from time to time. There is no upper age limit for the Institute employees who are treated as departmental candidates.
