Recruitment for Engagement of a Consultant(Environmental Health and Safety)

- a) Translational Health Science and Technology Institute (THSTI) is an autonomous Institute of the Department of Biotechnology, Ministry of Science and Technology, Govt. of India. The institute is an integral part of the interdisciplinary NCR Biotech Science Cluster located at Faridabad, and is designed as a dynamic, interactive organization with the mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into tangible products to improve human health.

The NCR Biotech Science Cluster (NCR-BSC) has been established in Faridabad within the National Capital Region to foster biotech innovation through sharing of resources and expertise of the various member institutions of the cluster. Processes have been put in place to achieve the objectives of the cluster to synergise functioning of the various cluster institutions at the operational and scientific levels. NCR Biotech Science Cluster aims to provide strategic support to national, regional research organizations in creation and integration of scientific, technical and business related frameworks that would accelerate and translate discoveries and carry out validation and transfer of product technologies to enterprises. - b) This recruitment is to engage Consultant (Environmental Health and Safety) for THSTI:

- Assist THSTI to obtain necessary approvals for compliances from various approval boards related to Environmental health and safety.
- Provide required training to institutional EHS committee members and other scientific staff, faculty members and employees of THSTI.
- Assist with development and maintenance of training processes to ensure that required environmental, health and safety training is defined, addresses required content and is tracked to completion.
- Help institute while working with institutional committee in design and compilation of hazardous (biological and chemical) and non-hazardous waste disposal guidelines and SOPs.
