## Applications/Nominations are invited for the Post of Dean / Sr. Professor, THSTI

- a) Translational Health Science and Technology Institute (THSTI) is an autonomous institute of the Department of Biotechnology (DBT), Ministry of Science & Technology, Government of India. THSTI is a part of the interdisciplinary Biotechnology Science Cluster at Faridabad, Haryana in the National Capital Region (NCR). The institution is a dynamic enterprise with a mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into products to improve human health.
- b) THSTI has built several inter-institutional collaborations and connectivity with industry supported by well-trained teams of research and laboratory staff. This foundation has helped pursuit of thematic research programmes which can be broadly categorized as, (a) Infectious diseases and Immunology (b) Maternal and child health, (c) Non communicable disease d) Multidisciplinary clinical and translational research. These will be strengthened by the four core facilities viz. Small Animal Facility, Data Management Center, Biorepository and Bioassay Laboratory that will serve not only the research programmes of THSTI, but also the National Capital Region Biotech Science Cluster and other academic and industrial partners.
- c) Applications are invited from leaders who are indian nationals / persons with OCI status to fill up three positions of Dean on direct recruitment / deputation basis. The actual number of positions that will be filled will depend upon identification of suitable candidates. In case of non-availability of suitable candidates for the post of Dean, the post will be operated at the lower level of Senior Professor.
- d) The Dean will be the administrative head/mentor of the thematic research programs as mentioned above and may be delegated additional supervisory responsibilities of academics / students affair / campus matters / international relationships / etc. The Dean/Sr. Professor of THSTI will report to the Executive Director.

#### f) Compensation:
