APPLICATIONS ARE INVITED FOR THE FACULTY POSITION, THSTI

- a) BRIC-Translational Health Science and Technology Institute (THSTI) is an Institute of the Biotechnology Research and Innovation Council, Department of Biotechnology, Ministry of Science & Technology, Govt. of India. The institute is an integral part of the interdisciplinary NCR Biotech Science Cluster located at Faridabad, and is designed as a dynamic, interactive organization with the mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into products to improve human health.
- b) BRIC-THSTI has built several inter-institutional collaborations and connectivity with industry supported by well-trained teams of research and laboratory staff. THSTI has established various centres namely (a) Centre for Maternal and Child Health, (b) Centre for Viral Therapeutics and Vaccines (c) Centre for Tuberculosis Research (d) Centre for Microbial Research, (e) Centre for Immunobiology and Immunotherapy (f) Centre for Drug Discovery (g) Clinical Development Services Agency (h) Computational and Mathematical Biology Centre (i) Centre for Bio-design and Diagnostics. These centres are strengthened by many core facilities viz. Bioassay Laboratory, Biorepository, Biosafety Level -3 Lab, Data Management Centre, Immunology Core laboratory, Multi-OMICS facility, Experimental Animal Facility, Vaccine design and Development facility, School of Innovation in Bio design etc that serve as huge resources for the research programmes of THSTI and also the National Capital Region Biotech Science Cluster and other academic and industrial partners.

- c) Applications are invited from eligible candidates who are Indian nationals / persons with OCI status to fill up the following regular faculty position:

d) Compensation:

1. In addition to the usual pay & allowances as admissible, the selected incumbent will be entitled to other benefits such as a semi-furnished on-campus housing (in lieu of HRA), medical reimbursement, telephone expenses reimbursement, newspaper allowance, children education allowance, Leave Travel Concession, New Pension Scheme contribution, transport allowance, support for national and international conference etc. as per the Government of India/THSTI rules.

e) Other benefits:

1. The incumbent will mentor other scientists / post-doctoral fellows / Ph.D. students.
2. The incumbent will be encouraged to generate extramural funding from various Government and non-government funding agencies.
3. The incumbent will have access to state of the art technologies available with the Institute and research leads from other related centres of THSTI and other Institutions.
4. The incumbent will be permitted to undertake consultancy services on behalf of the institute and retain a portion of the consultancy fees as per the Bye-laws of the institute.

f) General Terms and conditions:

1. All educational, professional and technical qualification should be from a recognized Board/University.

2. Persons working in Govt. / PSUs / autonomous bodies should apply through proper channel or produce a relevant 'No Objection Certificate' while appearing in the selection process failing which their candidature will be rejected.
3. The experience requirement specified above shall be the experience acquired after obtaining the minimum educational qualifications specified for the post. The candidates are required to satisfy themselves before applying that they possess at least the essential qualifications/experience laid down for the post. No enquiry asking for advice as to eligibility will be entertained.
4. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview/presentation.
5. If any document/ certificate furnished is in a language other than Hindi or English, a transcript of the same in English duly attested by a Gazetted officer or notary is to be uploaded.
6. Closing date of online application will be the **CRUCIAL DATE** for determining eligibility with regard to age, essential qualification/experience etc.
7. Although the above position is not reserved for the Persons with benchmark disabilities (PwBD) but the position has been identified as suitable for them under following categories:
 - a) Locomotor disability – OA, OL, OAL including leprosy cured, dwarfism and acid attack victims
 - b) Hard of hearing (HH)
 - c) Low vision (LV)
 - d) multiple disabilities from amongst persons under clauses (a) to (c) excluding deaf-blindness
8. Age and other relaxations for direct recruits, departmental candidates and THSTI employees :

- 10 Age relaxation as per government norms will be provided duly ensuring at least 5 years remaining service for superannuation (60 years).

- 11 Number of positions to be filled will be as per the Institute's need and availability of the suitable candidates.
- 12 In case a large number of applications are received, screening will be done to limit the number of candidates to those possessing higher/relevant qualification and experience.
- 13 Only shortlisted candidates will be called to attend the selection process.
- 14 All results/notifications related to this Recruitment Notice will only be published on our website. Therefore, the candidates are advised to visit THSTI website regularly.
- 15 All future communications related to the selection process, will only be made through email.
- 16 With regard to any provisions not covered in this notification, the bye laws of THSTI / Govt. of India rules / guidelines shall prevail.
- 17 Canvassing/providing false information in any form will be a disqualification.

h) How to apply:

I. Documents to be kept handy before filling up the online application: (all the documents except passport size photo and signature should be in pdf format) :

- Post-Graduation degree certificate /final mark sheet
- Ph.D/MD or equivalent degree certificate
- Relevant experience certificates
- List of publications
- Five best publications
- List of patents
- Caste/Disability certificate in the format prescribed by the Govt. of India, if applicable
- Forwarding letter / NOC from the current employer in the case of candidates working in Govt. / PSUs / autonomous bodies

II. Procedure for filling up online application:

- i) The eligible and interested candidates may apply online at the Institute's website www.thsti.res.in/career. Applications through any other mode will not be accepted.
- ii) The following will be the step wise procedure-

 - B) Step 2 : Uploading of documents
 - C) Step 3 : Payment of application fee
 - The payment can be made by using Debit Card / Credit Card / Internet Banking / UPI.
 - Once payment is made, no correction / modification is possible

If the same is noticed after the appointment, the candidate will be terminated following due process.
